

DEED OF VARIATION TO THE FUNDING AGREEMENT

THIS DEED is made the 13 day of January 2022

BETWEEN

- 1) The Secretary of State for Education (the "**Secretary of State**"); and
- 2) John Taylor MAT, (the "**Company**") a charitable company incorporated in England and Wales with registered number 07421140, together, the "**Parties**".

INTRODUCTION

- A. The Parties entered into a funding agreement dated 29 June 2018 (the "**Funding Agreement**") relating to the establishment, maintenance and funding of an Academy known as Winshill Village Primary and Nursery School in accordance with the Funding Agreement.
- B. The Parties now wish to vary and amend certain terms and conditions of the Funding Agreement in accordance with the terms of this Deed.
- C. This Deed is supplemental to the Funding Agreement.

1. INTERPRETATION

- 1.1 Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Funding Agreement.

2. VARIATION OF THE FUNDING AGREEMENT

- 2.1 The Parties agree that with effect from the date of this Deed the Funding Agreement shall be amended as follows:

The age range on Page 4 of the Funding Agreement be changed to 2-11;

In clause 2.B "3-11" shall be deleted and replaced with "2-11"; and

Any other references to age range be considered amended as above and construed accordingly.

- 2.2 Except as varied by this Deed, the Funding Agreement shall remain in full force and effect.

3. Governing law and jurisdiction

- 3.1 This Deed, and any disputes or claims arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with English law.
- 3.2 The parties irrevocably agree that the English courts have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).


